C.9 Cox Proportional Hazards Model

In a study of peritonitis disease, survival duration (in years) was compared between two regimens (control and experimental). The survival has been taken to be affected by severity of disease at admission (assessed by APACHE score), sex and age in the two groups. These are the covariates in this example. The uncensored values denote death within the follow-up period whereas censored denotes both lost-to follow-up and alive subjects at the end of the study.

Basic assumption of survival analysis is that censoring should have nothing to do with the survival pattern—both censored and uncensored person should have similar characteristics. To test this, first unpaired *t*-tests should be applied to compare the mean APACHE score in censored and uncensored subjects.

Command to run unpaired *t*-test to compare the APACHE score in censored and uncensored group:

T-TEST GROUPS=Censored(0 1) /VARIABLES=APACHEatadmission /CRITERIA=CI(.95).

This commands run the unpaired t-test to compare the mean APACHE score in censored (coded as 0) and uncensored (coded as 1), CRITERIA= CI(.95) calculates the 95% confidence interval for mean difference. The following table displays the mean, SD, standard error of mean of APACHE score in censored and uncensored subjects and the next table results of *t*-test.

Independent Samples Test

Levene test for equality of variances is applied to check the equality of variances in APPACHE score in censored and uncensored groups before deciding which *t*-test result is applicable. Levene test not significant (P = 0.325) represents no violation of homogeneity of variance assumption. The *P*-value of *t*-test for equal of variances can be used. This found no significance difference in mean APACHE score in censored and uncensored values.

Chi-square test is applied to compare proportion of males and females in censored and uncensored subjects.

This command displays the following contingency tables between sex and censoring and runs the chi-square and other similar tests. Cell frequencies are not small and chi-square results can be believed. No chi-square is significant.

Levene test is not significant – thus equal variances can be assumed. Average age at onset in censored observations is 49.53 years and in uncensored is 50.00 years and the difference is not statistically significant (P = 0.879). All the three covariates are similar in subjects with censored and uncensored survival. Thus this basic assumption is fulfilled.

As an additional enquiry, you can test whether APACHE score at admission differed between males and females. For this the command is as follows:

Although APACHE score is higher in males but not statistical significant. Just to explore the data further, find correlation between APACHE score and age at onset of the disease. This is not needed for this problem.

Following tables displays the results of *t*-test. In this case, Levene test for equality of variances is significant and tells that homogeneity of variance assumption is violated by these data. The

P-value (P = 0.429) of *t*-test for unequal variances found no significant difference in mean age at onset in the two groups.

APACHE score at admission in the two groups also is not significantly different (P = 0.803). A chi-square test for equality of sex distribution should also be done but that is not shown here. These tests establish that the two groups were not different to begin with. Assuming that all other factors not in the model are also same in the two groups, any difference in survival can be attributed to the difference in regimens.

After this exploration, ground is set for **Cox proportional hazard model**. First is to confirm that the hazards are proportional or not.

Command to run whether the hazard is proportional between the two groups:

COXREG DurationofsurvivalYears /STATUS=Censored(0) /STRATA=Group /PLOT HAZARDS LML.

This command tests the proportionality of hazard assumption between the two groups. The option STATUS = Censored(0) represents event has happened (death) in this command. Many would like it to be coded as 1 but that does not matter so long as we know. The variable Group was declared as STRATA instead of covariate so that this comparison can be done. PLOT command displays log minus log (LML) hazard for each group to visually check the proportionality assumption.

The following table gives the data summary. Seventeen out of 80 observations are censored and these are nearly equally divided in the two groups.






Figure C.9(a) displays the cumulative hazard for both the groups. Cumulative hazard at 5 years is much more than at 1 year. The difference between the two hazard curves remains proportional over the time. This proportionality is easily seen in the Figure C.9(b) on LML hazard. These plots are almost parallel for the groups.

Thus, Cox proportional hazard model is suitable for these data.

This command runs Cox-regression for survival considering survival duration as the dependent time variable. STATUS defines censoring with zero for death. PATTERN By Group option plots the survival curve for both the regimens separately. CONTRAST options are for binary variables Sex and Group. By default last category is considered as the reference category but for sex first category (female) was selected as reference category and for Group 1 is automatically selected as reference category. Age at onset and APACHE score are entered as continuous variable in the model. METHOD option is for the method of selecting the variable – here ENTER method is used that forced all the four independents in to the model. PLOT option displays the survival curve. The PRINT = BASELINE option displays the table for baseline hazard $h_0(t)$ at different time points and $h_1(t)$ value at same time points at the mean level of the covariates.

The following table displays the frequencies and coding scheme of the categorical variables. Test regimen was taken as reference (which is code for control in this case) and for sex female was taken as reference.

The APACHE score and Group are significant predictor for mortality. exp(B) is the relative risk and represents the change in risk with each unit change in the value of the covariate. For example each unit increase in the APACHE score is expected to increase the risk of mortality by 5.2% relative to control because exp(B)=1.052. Similarly test regimen decreases the risk of mortality by nearly one-half compared with control since $\exp(B)=0.511$. The regression equation can be written as:

 $h_1(t) = h_0(t) \times exp^{[0.000035 \times Age + 0.051 \times APACHE + 0.207 \times sex - 0.672 \times group]}$ The regression equation for control (Group=0) is $h_1(t) = h_0(t) \times exp^{[0.000035 \times Age+0.051 \times APACHE+0.207 \times sex-0.672 \times 0]}.$ The regression equation for test regimen (Group=1) is $h_1(t) = h_0(t) \times exp^{[0.000035 \times Age + 0.051 \times APACHE + 0.207 \times sex - 0.672 \times 1]}.$

For example at survival duration 4 years, the baseline cumulative hazard rate $h_0(t) = 0.349$ and cumulative hazard rate at mean values of covariates is

 0.672×0.5] = 0.349×exp(1.684) = 0.349×5.387 = 1.88. The value of h_1 at 4 years from the table is 1.866 that is close to the 1.88. The difference is due to rounding off in calculations.

You can calculate the cumulative hazard for each regimen separately and for various combinations of values of the covariates by substituting the values in the regression equation.

Survival Function for patterns 1 - 2




FIGURE C.9(c) Survival curve in the two groups

The following table displays the mean and median duration of survival in two regimen groups, and their SEs and CIs. The median survival duration for test regimen (group = 1) is 2.9 years which is higher than 2.1 years for control group. Note that mean is much higher than median in this case.

Figure C.9(d) gives the two survival curves again, this time with + sign for censored values. These are slightly different from the curves obtained earlier by Cox method.




FIGURE C.9 (d) Survival curves in the two groups by the Kaplan-Meier method
